



We champion polar research and advocate for its prominence, helping to align priorities at national and regional levels to benefit European society.



European Polar Board's Mission

To promote, coordinate and **advance** European research at high latitudes by providing a single collaborative platform for European polar researchers.







## **Promote:**

Strengthen connections with the worldwide polar research community, and be the central organisation to bodies seeking collaboration with European polar organisations.

> In order to **promote** European polar research, the EPB seeks to:

- Be a strong voice, proactively communicating with policymakers at the highest levels to achieve a greater prioritisation of polar issues, advising on polar matters and representing the European polar research community throughout Europe and beyond.
- Represent European research in polar regions in an international setting, including as part of international bodies and frameworks, and effectively communicate key achievements and successes in European polar research to stakeholders.



- Work towards making the EPB, European polar institutions, and polar research as a whole more open and accessible to all, to ensure opportunities are available to all stakeholders, and ensure the EPB is open to external advice and ideas.

### Implementation:

To promote European research in both the Arctic and Antarctic, the EPB will initiate discussion of polar issues through publications, briefings, online communications and interdisciplinary events, pushing for greater prominence of polar issues throughout Europe.

## **Coordinate:**

Provide a platform for greater European coordination and integration for logistics, infrastructures, and scientific cooperation in polar regions.

> In order to **coordinate** European research in polar regions, the EPB seeks to:

- Forge, maintain, and develop strong networks among European and international organisations and individual researchers, catalysing collaborations between researchers and between organisations throughout Europe.
- Identify, contribute to, and help expand existing polar networks, thus facilitating participation of European researchers in international networks, and of international partners in European research.

• Align the objectives of polar researchers and research organisations throughout Europe, identifying mutual priorities and potential collaborations.

### Implementation:

To coordinate European research in high latitudes, the EPB will actively foster useful complementarities between national and European priorities, and maintain relevant products from European initiatives.








## **Advance:**

# **Implementation Plan**

In order to fulfil the EPB Strategy, an Implementation Plan will guide our activities over the next five years. The Implementation Plan details initiatives, activities and outputs, so that the progress of the EPB can be followed by Members and stakeholders. The EPB Implementation Plan is aligned with our Mission to advance, coordinate and promote European research in polar regions; the EPB will follow the Implementation plan to realise our Vision as the strong and independent voice of European polar research.

The EPB Implementation Plan is structured around eight Action Areas:

- 1. Aligning polar priorities
- 2. Infrastructures
- 3. Data, information and observations
- 4. Policy advice
- 5. Representing the polar research community in Europe
- 6. Representing European polar research internationally
- 7. Outreach and communications
- 8. Progress monitoring

# **Progress Monitoring**

This EPB Strategy will be implemented over the period 2017-2022. An internal review of progress will be performed for the mid-point of the Strategy implementation, followed by an external review in 2022 before entering the next Strategy cycle.

## **Future**

This Strategy will position the EPB in a leading role, driving momentum to address emerging priorities and developments in the European and international polar research communities, with an open and participatory approach.
